ANIMAL CONTROL OFFICERS HOLD 25TH ANNUAL TRAINING SEMINAR

On September 16, 2010 the Department of Agriculture, in conjunction with the Connecticut Municipal Animal Control Officers Association, held their 25th annual training seminar at the Mashantucket Pequot Museum in Ledyard. About 150 animal control officers (ACO's) from around the state, and several from Rhode Island, attended the conference.

Dr. Bruce Sherman, Director of the Bureau of Regulation and Inspection at the Department of Agriculture, spoke first to the assembly and updated them on current issues facing the Department. State Animal Control Supervisor Raymond Connors talked about recently enacted legislation concerning domestic animals and answered questions about its enforcement. Animal Population Control Program director Frank Ribaldo highlighted the program's success and announced the resumption of the low-income and feral cat grant programs for spaying and neutering Connecticut dogs and cats.

Dr. Randall Nelson of the Connecticut Department of Public Health spoke about the biology of rabies. He explained how the incubation period of rabies impacts the length of quarantine in different scenarios. For example, an unvaccinated dog bitten by a rabid raccoon may take up to six months or more to exhibit signs of the disease. However, if an animal is shedding virus in the saliva and bites a human, that animal will be dead within the fourteen day quarantine period. Dr. Nelson, a veterinarian and an epidemiologist, also talked about the ways public health officials view diseases and how that differs from the way a personal physician views an individual patient who has been exposed to the disease.

Tim Brennan, supervisor of the virology lab at the Department of Public Health (DPH), presented a very different view of rabies in Connecticut. Tim's lab handles all the suspect rabid animals and determines if they have the disease. Attendees got to look through Tim's eyes as he examines those animals and runs the rabies tests. Using photographs, we watched Tim dissect a suspect rabid animal, take samples, run the test and see the positive versus negative test results. It was a unique perspective, to say the least. Now every animal control officer should understand why the lab asks to double-bag submissions and attach the proper paperwork. He also explained that rabies-suspect large animals (livestock) should be submitted to UConn's Pathobiology Lab because they are better equipped to handle the larger species than is the DPH lab.

During the breaks, attendees were able to visit vendor displays selling everything from police equipment, trapping equipment and invisible fences to animal crematoriums. The Connecticut Veterinary Medical Association had a display highlighting their Foundation which supports the CT State Animal Response Teams (CT SART).

The final speaker was Gretchen Ziemer, a master's degree candidate from the University of Maine, who spoke on sexual assault against animals. Although this was difficult information to hear, Gretchen provided valuable tips on the collection of evidence in order to successfully prosecute offenders. The internet has encouraged the growth of this offense and is something with which all officers need to be aware. Several members of municipal police departments as well as one chief of police attended to hear about this type of crime.

Another successful conference came to a close with the awarding of the Paul A. Deneault Animal Control Officer of the Year. The 2010 honoree was Terry Foss of Plainfield Animal Control. Officer Foss died last November as the result of injuries suffered while in the line of duty. Plainfield Police Chief Robert Hoffman spoke movingly about how Terry's tragic death has inspired him to become more knowledgeable about the dangers animal control officers face daily on the job. Plainfield's animal control officers are now trained on the proper use of weapons they have been issued to assure their own safety and the safety of the public. Chief Hoffman urged other departments to follow Plainfield's lead.
